Footnote: "Political activity," as defined in Section 1(o) of the Act, means any activity which the person engaging in believes will, or that the person intends to, in any way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

CONTRACT FOR SERVICES

This contract is entered into between the Republic of Turkey, Embassy of Turkey ("the Client"), 2525 Massachusetts Avenue NW, Washington, DC 20008, and Ballard Partners, Inc. ("the Firm"), 403 East Park Avenue, Tallahassee, FL 32301.

Recitals

Whereas, the Client wishes to retain the services of the Firm in order that the Firm may provide strategic consulting and advocacy services to the Client in connection with its business with the United States government; and

Whereas, the Firm wishes to provide such representation as the Client may from time to time require; and

Whereas, the parties have agreed to the terms under which the Firm will represent the Client and wish to memorialize their agreement in writing;

Now, therefore, in consideration of the mutual covenants herein contained and intending to be legally bound hereby, the parties agree as follows:

1. Term of Agreement. This agreement shall become effective on May 15, 2017 and shall remain effective until May 14, 2018. This agreement shall automatically renew for successive one-year periods on the anniversary of the effective date of the agreement unless either party terminates the agreement. Upon renewal this agreement may be terminated within thirty (30) days written notice by either party.

2. Duties of The Firm. It shall be the Firm's duty to consult with the Client and advocate on its behalf those issues the Client deems necessary and appropriate before the US Federal government. Issues and objectives may include, but are not limited to, enhancing US-Turkey bilateral relations, developing trade, investment and business opportunities, promoting Turkey as an energy hub, combatting terrorism and transnational threats, and supporting efforts to de-escalate the violence in Syria and create the conditions for a credible political resolution of the conflict. It shall further be the Firm's duty to inform the Client of developments in legislation and policy relevant to the Client's issues and objectives.

3. Duties of The Client. It shall be the Client's duty to provide the Firm the information necessary to best represent the Client. It shall also be the Client's duty to timely compensate the Firm for its services.

4. **Compensation.** The Firm shall receive from the Client \$125,000 a month, payable in quarterly installments for this agreement, plus the reasonable costs associated with the representation, including but not limited to, necessary registration fees; and travel expenses such as overseas hotel, air fare, car services and meals, excluding costs typically associated with the operation of an office, such as overhead, staff, and equipment. The fee shall be paid in quarterly installments of \$375,000, with the first installment being due immediately upon execution of this agreement; second installment due on August 15th; third installment due November 15th; fourth installment due February 15th; and continuing to be due on a quarterly basis until the termination of the agreement. The Firm will bill costs quarterly.

5. **Choice of Law.** This Agreement shall be governed by, and construed in accordance with, the laws of the Republic of Turkey. The Turkish Republic courts located in Ankara, Turkey shall be the venue for resolving any dispute related to the interpretation and application of this Agreement that cannot otherwise be settled amicably by the parties.
